RESOLUTION AWARDING A CONTRACT FOR THE 2021 COUNTY AID ROAD PROGRAM FOR THE COUNTY OF SALEM

WHEREAS, the Salem County Board of County Commissioners publicly advertised this Project and is in full compliance with the Public Contract Laws; and

WHEREAS, two (2) bids were received for the "2021 COUNTY AID ROAD PROGRAM FOR THE COUNTY OF SALEM" on Wednesday, July 10, 2024 at 11:0 AM; and

WHEREAS, provisions were made in the Specifications to Award the Contract to the LOWEST TOTAL AMOUNT BID to the best interest of the County of Salem; and

WHEREAS, "South State Inc." of Bridgeton, New Jersey did submit the Lowest Total Amount Bid for this Project, as per the attached "Summary of Bids"; and

WHEREAS, the Salem County Engineer has reviewed the bid documents and along with the County Administrator recommends approval of this project to "South State, Inc." of Bridgeton, New Jersey.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that a Contract be Awarded subject to the review and approval of the County Solicitor to said "South State Inc." for the "2021 COUNTY AID ROAD PROGRAM FOR THE COUNTY OF SALEM" for their Total Amount bid for the Base Bid and Alternate A of \$2,897,263.10 (Two Million, Eight Hundred Ninety-Seven Thousand, Two Hundred Sixty-Three Dollars and Ten Cents) subject to the approval of the Commissioners of the New Jersey Department of Transportation; and

BE IT FURTHER RESOLVED that the Director of the Board sign the Contract Documents and the Clerk of the Board attest to same on behalf of this Salem County Board of County Commissioners upon compliance by "South State, Inc." with the Bond and Insurance requirements of the Specifications.


