RESOLUTION AUTHORIZING THE RENEWAL OF A COOPERATIVE CONTRACT PURCHASING SYSTEM FOR THE COUNTY OF SALEM

WHEREAS, N.J.S.A 40A:11-11 and N.J.A.C. 5:34-7 et seq. authorizes counties to enter into County Cooperative Contract Purchasing System Agreements for contracting units located within the county's geographic boundaries to procure the provision and performance of goods and services for their own needs, subject to the specifications, terms and conditions set forth in the contracts awarded by the county; and

WHEREAS, the County of Salem has created the Salem County Cooperative Contract Purchasing System - Identifier #CK05 for the benefit of participating contracting units; and

WHEREAS, the Salem County Board of County Commissioners consider it to be in the best interest of the County of Salem and its participating members to continue the Salem County Cooperative Contract Purchasing System - Identifier #CK05 and renew the agreement for a five (5) year period commencing September 4, 2024, and terminating September 3, 2029; and

WHEREAS, the County Cooperative Purchasing form CCCP-1917 requesting renewal of a County Cooperative Contract Purchasing System, will be submitted to the Division of Local Government Services for approval.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that:

- 1. Pursuant to the provisions of N.J.S.A. 40A:11-11 and N.J.A.C. 5:34-7 et seq. the Salem County Board of County Commissioners hereby authorizes the renewal of the Salem County Cooperative Contract Purchasing System - Identifier #CK05.
2. The County of Salem shall be responsible for submitting a certified copy of this resolution, along with the executed County Cooperative Contract Purchasing Agreement – CCCP-1917, and any required documents in connection therewith to the Division of Local Government Services within the State Department of Community Affairs.
3. The agreement shall be renewed for a five (5) year period commencing September 4, 2024, and terminating September 3, 2029.
4. The Commissioner Director and the Clerk of the Board shall be authorized to execute said contracts upon compliance by the firm with all requirements and specifications.
