RESOLUTION AWARDING A CONTRACT FOR FURNISHING AND DELIVERING ROCK SALT FOR THE COUNTY OF SALEM AND THE MEMBERS OF THE SALEM COUNTY COOPERATIVE PRICING SYSTEM IDENTIFIER NUMBER 75-SCCPS

WHEREAS, The Salem County Purchasing Agent, as authorized contracting Agent for the Board of County Commissioners for the County of Salem, has requested, received and opened sealed bids on August 27, 2024, 11:00 am prevailing time for Furnishing and Delivering Rock Salt for the County of Salem and Members of the Salem County Cooperative Pricing System (#75-SCCPS). The receipt of said bids were duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, bids were received from three (3) bidders as follows:

WHEREAS, it has been determined that the company of **Morton Salt** has substantially met the necessary qualifications for the fulfillment of this contract, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem; and

WHEREAS, the period of this contract will commence on September 1, 2024, and will terminate August 31, 2025, with two (2) additional one (1) year renewal options; and


WHEREAS, the Salem County Treasurer has certified that the funding for this contract in 2024 shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the County’s temporary and/or permanent budgets.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem as follows:

1. The Salem County Board of County Commissioners of the County of Salem hereby awards a contract for Furnishing and Delivering Rock Salt for the County of Salem and the members of the Salem County Cooperative Pricing System Identifier Number 75-SCCPS subject to the review of the County Solicitor, Morton Salt, 444 West Lake Street, Suite 2900, Chicago, IL 60606

2. Cost per ton shall not exceed \$71.82 (Seventy-One Dollars and Eighty-Two Cents) and total cost over the term of the first-year contract shall not exceed \$574,560.00 (Five Hundred Seventy-Four Thousand, Five Hundred Sixty Dollars and Zero Cents) with the cost of CY 2024 not to exceed \$80,000 (Eighty Thousand Dollars and Zero Cents).
3. The contract commences September 1, 2024, and will terminate August 31, 2025, with two (2) additional one (1) year renewal options. This shall be completed in full accordance with the terms and conditions of the contract.
4. The Board of County Commissioners Deputy Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.


