**RESOLUTION TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH MEDIVERSITY HEALTH, LLC. (DR. AHSAN ABDULGHANI, MD) FOR EXECUTION THROUGH THE MEDICAL ASSISTED TREATMENT (MAT) GRANT**

**WHEREAS**, the Salem County Correctional Facility (SCCF) and MediVersity Health LLC. (Dr. Ahsan Abdulghani, MD) wish to enter into a Memorandum of Understanding (MOU) regarding the Medical Assisted Treatment (MAT) program; and


**WHEREAS**, the purpose is to offer adult inmates with opioid addiction an opportunity to be provided with medication-assisted treatment and counseling while incarcerated at the Salem County Correctional Facility; and

**WHEREAS**, the Salem County Correctional Facility (SCCF) will utilize authorized funds from the New Jersey Department of Health awarded MAT grant to pay for any treatment services provided by MediVersity Health LLC. (Dr. Ahsan Abdulghani, MD).

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of County Commissioners that:

1. Salem County shall pay MediVersity Health LLC. (Dr. Ahsan Abdulghani, MD), \$2,276.53 per client for counseling and medication when needed, not to exceed \$17,500.00 (Seventeen Thousand Five-Hundred Dollars and Zero Cents) per year.
2. The Commissioner Director and Clerk of the Board shall be authorized to execute said agreement upon compliance by the firm with all requirements and specifications.

I hereby certify the foregoing to be a true resolution adopted by the Salem County Board of County Commissioners on September 4, 2024.


