RESOLUTION RENEWING A CONTRACT FOR PROVIDING INMATE DENTAL CARE FOR THE SALEM COUNTY CORRECTIONAL FACILITY

WHEREAS, the Salem County Purchasing Department, as authorized Contracting Agent for the Board of County Commissioners of the County of Salem requested, received, and opened sealed proposals on March 27, 2021, at 2:00 PM prevailing time for Providing Inmate Dental Care for the Salem County Correctional Facility. The receipt of said bids were duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, it was determined that the company of Dentrust Dental, P.A., also known as Dentrust Optimized Care Solutions substantially met the necessary qualifications for the fulfillment of the contract, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem. Said bid documents have become a part of the contract; and

WHEREAS, the Board of County Commissioners of the County of Salem adopted Resolution 2021-226 awarding a contract to Dentrust Dental P.A.; and

WHEREAS, the original contract provided for two (2) one (1) year extensions and Dentrust Dental, P.A. and the Salem County Board of County Commissioners, along with the Salem County Correctional Facility are interested in exercising the second one (1) year renewal of said contract with the same terms and conditions as outlined in the bid specifications and proposal.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Salem as follows:

1. The Salem County Board of County Commissioners hereby awards a renewal contract for the provision of Inmate Dental Care for the Salem County Correctional Facility, subject to the review of the County Solicitor, to Dentrust Dental, P.A., 6097 Easton Road, Pipersville PA 18947 the cost not to exceed \$39,696.00 (Thirty-Nine Thousand, Six Hundred Ninety-Six Dollars and Zero Cents).
2. The contract shall commence retroactively on June 16, 2024, and terminate on June 15, 2025, with no additional renewals or extensions. This shall be completed in full accordance with the terms and conditions of the contract.
3. The Commissioner Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.


