RESOLUTION ESTABLISHING A MULTI-WAY STOP CONTROL AT THE INTERSECTION OF WOODSTOWN-PEDRICKTOWN ROAD, COUNTY ROAD #602 AND POINTERS-AUBURN ROAD, COUNTY ROAD #646 IN OLDMANS TOWNSHIP

WHEREAS, a safety concern exists at the Intersection of Woodstown-Pedricktown Road, County Road #602 and Pointers-Auburn Road, County Road #646 in Oldmans Township; and

WHEREAS, the Salem County Board of County Commissioners issued a Contract to "Pennoni Associates, Inc." to evaluate the aforementioned intersection for a formal Traffic Study of the intersection for recommended safety improvements; and

WHEREAS, the County Engineer has reviewed the formal Traffic Study prepared by "Pennoni Associates, Inc." which supports the establishment of a MULTI-WAY STOP Control at the Intersection. A copy of that portion of the Traffic Study associated with this Intersection is attached hereto; and

WHEREAS, the Salem County Board of County Commissioners approved the full Traffic Study under Resolution No. 2024-179, entitled: Resolution Restricting Truck Traffic on Salem County Road #642, East Mill Street and For Large Wheelbase Vehicles and Reducing Weight Limit for Pedricktown Bridge (Salem County Bridge #1700-199) Oldmans Township, adopted on April 17, 2024.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that the establishment of a MULTI-WAY STOP Control, at the Intersection of Woodstown-Pedricktown Road, County Road #602 and Pointers-Auburn Road, County Road #646, in the Township of Oldmans is hereby approved; and

BE IT FURTHER RESOLVED that a work order be given to the Public Works Department by the County Engineer outlining the changing of the existing intersection to a Four-Way Stop Intersection along with the location and type of signs to be erected and the painting of the appropriate traffic markings to support the establishment of the MULTI-WAY STOP Control; and

BE IT FURTHER RESOLVED that a copy of this Resolution and accompanying Traffic Study will be submitted to the Commissioner of the New Jersey Department of Transportation for informational purposes only.
