RESOLUTION AUTHORIZING CHANGE ORDER #1 TO THE CONTRACT FOR COUNTY PLANNER FOR THE COUNTY OF SALEM

WHEREAS, the Salem County Board of County Commissioners awarded a contract to the Alaimo Group on January 3, 2024 per Resolution 2024-056; and

WHEREAS, additional County Planner expenses are anticipated to be incurred and the Administrator is recommending Change Order #1 in the amount of \$10,000.00 (Ten Thousand Dollars and Zero Cents), that will increase the original contract from \$10,000.00 (Ten Thousand Dollars and Zero Cents) to \$20,000.00 (Twenty Thousand Dollars and Zero Cents) to the Alaimo Group; and

WHEREAS, the award of this contract will be published in the official newspaper, per N.J.S.A. 40A:11-5(1)(a)(i); and

WHEREAS, all the other terms of the original contract shall remain in force.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that

1. The Salem County Board of County Commissioners authorizes and approves Change Order #1, for the additional amount of \$10,000.00 (Ten Thousand Dollars and Zero Cents), increasing the contract to \$20,000.00 (Twenty Thousand Dollars and Zero Cents) for additional County Planner expenses necessary for the NJ State Planning Commissions Development and Redevelopment Cross-acceptance process.
2. The Salem County Treasurer shall certify to the Salem County Board of County Commissioners that the funds are available for the payment of additional expenses.
3. The Commissioner Director and the Clerk of the Board shall be authorized to execute the change order upon compliance with the firm with all requirements and specifications of original contract.


