**RESOLUTION AUTHORIZING A MEMORANDUM OF UNDERSTANDING BETWEEN THE COUNTY OF SALEM AND THE PEDRICKTOWN FIRST AID & RESCUE SQUAD FOR THE PROVISION OF EMERGENCY MEDICAL SERVICES**

**WHEREAS**, in order to help defray the costs associated with providing emergency medical services to residents within the County of Salem, the County of Salem wishes to incentivize the continuation of services provided by its Municipalities; and

**WHEREAS**, the County desires to enter into a Memorandum of Understanding with the Pedricktown First Aid & Rescue Squad to provide Emergency Medical and Ambulance Services ("Services") within the County by paying the Company \$150.00 per call for all calls responded to by the Company within the confines of the County of Salem; and

**WHEREAS**, the Pedricktown First Aid & Rescue Squad is a provider of Emergency Medical Ambulance services in the State of New Jersey, and agrees to perform the Services for the County as provided in the Agreement; and


**WHEREAS**, N.J.S.A. 40:5-2., specifically permits a county to make a voluntary contribution to any duly incorporated first aid and emergency or volunteer ambulance or rescue squad association of the county; and

**WHEREAS**, The Salem County Board of County Commissioners now wish to authorize the aforesaid Memorandum of Understanding with the Pedricktown First Aid & Rescue Squad.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of the County of Salem as follows:

1. The Memorandum of Understanding between the County of Salem and the Pedricktown First Aid & Rescue Squad for the Provision of Emergency Medical Services is hereby approved in the form on file with the Clerk of the Board and in the form as approved by County Counsel and subject to non-material changes.
2. The Agreement shall commence retroactively on January 1, 2024, and terminate on June 30, 2025.
3. The Director, or his designee, and the Clerk of the Board are hereby authorized to execute any and all documents, if necessary, to effectuate the full intent and purpose of this Agreement.
