RESOLUTION AWARDING A RENEWAL CONTRACT FOR SUPPLYING AND DELIVERING SHERIFF AND CORRECTIONAL OFFICERS UNIFORMS AND COMMUNICATION CENTER UNIFORMS FOR THE COUNTY OF SALEM

WHEREAS, the Salem County Purchasing Agent, as authorized contracting Agent for the Salem County Board of County Commissioners requested, received, and opened sealed proposals on November 4, 2021, at 11:00 AM prevailing time for Supplying and Delivering Sheriff and Correctional Officer Uniforms and Communication Center Uniforms for the County of Salem. The receipt of said bids was duly advertised in accordance with the law and in such case made and provided; and

WHEREAS, it was determined that the company of Action Uniform Company, LLC, provided the lowest responsible and responsive bid and substantially met the necessary qualifications, and further has provided the documentation necessary to successfully fulfill the requirements of the County of Salem; said bid documents shall become a part of the contract; and

WHEREAS, the Salem County Board of County Commissioners adopted Resolution 2021-386 awarding a Contract to Action Uniform Company LLC; and

WHEREAS, the contract provided for two (2) additional one (1) year renewal options; and

WHEREAS, Action Uniform Company, LLC and the Salem County Board of County Commissioners, along with the Salem County Sheriff's Department, Corrections Facility and Communication Center are interested in exercising the second one (1) year renewal option of said contract with the same terms and conditions as outlined in the bid specifications and proposal.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

1. The Salem County Board of County Commissioners hereby awards a renewal contract for Supplying and Delivering Sheriff and Correctional Officer Uniforms, and Communication Center Uniforms for the County of Salem subject to the review of the County Solicitor, to Action Uniform Company, LLC., 1500 S. New Road, Pleasantville, NJ 08232, the cost of which will not exceed \$127,318.00 (One Hundred Twenty Seven Thousand Three Hundred Eighteen Dollars and Zero Cents)
2. The contract shall commence on November 17, 2024, and terminate on November 16, 2025, with no additional renewals available. This shall be completed in full accordance with the terms and conditions of the contract.
3. The County Commissioner Director and the Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.


