**RESOLUTION AUTHORIZING CHANGE ORDER #2 TO THE CONTRACT FOR LABOR COUNSEL FOR THE COUNTY OF SALEM**

**WHEREAS**, the Salem County Board of County Commissioners awarded a contract to Archer & Greiner, PC and adopted resolution 2024-048 for Labor Counsel for the County of Salem; and

**WHEREAS**, Resolution 2024-279 authorized Change Order #1 for \$73,000.00 (Seventy-Three Thousand Dollars and Zero Cents) for additional Labor Counsel expenses, increasing the original \$100,000.00 (One Hundred Thousand Dollars and Zero Cents) to \$173,000.00 (One Hundred Seventy-Three Thousand and Zero Cents); and

**WHEREAS**, additional Labor Counsel expenses will occur and the Office of Administration is recommending Change Order #2 in the amount of \$100,000.00 (One Hundred Thousand Dollars and Zero Cents) needed to increase the revised contract from \$173,000.00 (One Hundred Seventy-Three Thousand Dollars and Zero Cents) to \$273,000.00 (Two Hundred Seventy-Three Thousand Dollars and Zero Cents) to Archer & Greiner, PC; and

**WHEREAS**, N.J.A.C. 5:30-11.6(d) does not require publication of the increase in the contracting units official newspaper when the increased amount is 20% of the original contract; and

**WHEREAS**, all the other terms of the original contract shall remain in force.

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of County Commissioners as follows:

1. The Salem County Board of County Commissioners authorizes and approves Change Order #2, for an additional amount of \$100,000.00 (One Hundred Thousand Dollars and Zero Cents), for additional Labor Counsel expenses needed for labor negotiations.
2. The Salem County Treasurer shall certify to the Salem County Board of County Commissioners that the funds are available for the payment of additional expenses.
3. The Commissioner Director and the Clerk of the Board shall be authorized to execute said contract upon compliance with the firm with all requirements and specifications


