RESOLUTION AMENDING 2024 CONTRACTS FOR PROVIDING DRUG AND ALCOHOL TREATMENT SERVICES (SOBER LIVING FUNDING) FOR THE SALEM COUNTY DIVISION OF MENTAL HEALTH & ADDICTION SERVICES

WHEREAS, the Salem County Board of County Commissioners through the Division of Mental Health & Addiction Services has awarded contracts for Drug and Alcohol Treatment Services commencing on January 1, 2024, and terminating on December 31, 2024, by Resolution #2024-068; and

WHEREAS, there was an increase in need for Maryville, Inc.'s Sober Living Funding and Salem County Division of Mental Health & Addiction Services wishes to amend the Sober Living Funding Services contract by increasing the amount of \$46,000.00 (Forty Six Thousand Dollars and Zero Cents) by \$12,000.00 (Twelve Thousand Dollars and Zero Cents) to be covered by the Opioid Settlement Fund for a balance of \$58,000.00 (Fifty Eight Thousand Dollars and Zero Cents); and

WHEREAS, the Salem County Treasurer has certified that the funding for this contract in 2024 shall be encumbered in accordance with N.J.A.C. 5:30-5.4 and this agreement shall further be contingent upon the availability and appropriation of sufficient funds for this purpose in the county's temporary and/or permanent budget.

NOW, THEREFORE BE IT RESOLVED, that the Salem County Board of County Commissioners approves the contract amendment authorizing Maryville, Inc. to increase funds allocated by the County of Salem in the amount of \$12,000.00 (Twelve Thousand Dollars and Zero Cents).
