RESOLUTION AWARDING A CONTRACT UNDER THE NEW JERSEY STATE APPROVED CONTRACT #42261 – T-0849 FOR ABOVE GROUND FUEL TANKS, ASSOCIATED EQUIPMENT INSTALLATION, TANK REMOVAL AND SYSTEM SERVICES

WHEREAS, the County of Salem desires to enter into an agreement with E.O. Habhegger Company, Inc. 334 North Washington Street, Hammonton, NJ 08037 for the installation of a new fueling system as part of the new above ground storage tank, in accordance with the New Jersey State Approved Contract #42261-T-0849, of which Salem County participates; and

WHEREAS, E.O. Habhegger has provided Salem County a pricing agreement in the amount of \$351,495.00 (Three Hundred Fifty One Thousand, Four Hundred Ninety Five Dollars and Zero Cents) for the labor and equipment involved for the project; and

WHEREAS, pursuant to N.J.S.A. 40A:11-12, local government contracting units may purchase materials, supplies, services or equipment without advertising for bids under any contract for the purchase of such items entered into on behalf of the State of New Jersey by the New Jersey Department of the Treasury, Division of Purchase and Property.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

1. That a contract is hereby awarded to E.O. Habhegger Company, Inc. 334 North Washington Street, Hammonton, NJ 08037 pursuant to participation in the New Jersey State Approved Contract #42261-T-0849, of which Salem County participates, in the amount of \$351,495.00 (Three Hundred Fifty-One Thousand, Four Hundred Ninety-Five Dollars and Zero Cents) for the labor and equipment needed for this project.
2. That said contract shall be charged to the capital account of C-04-55-897-024-902 – Public Works Improvements.
