RESOLUTION AWARDING A PROFESSIONAL SERVICES CONTRACT FOR AUBURN ROAD, COUNTY ROAD #602 FOR THE DESIGN AND PERMITTING OF STORMWATER MANAGEMENT IMPROVEMENTS FOR THE COUNTY OF SALEM

WHEREAS, the County of Salem seeks to secure the services of a Firm to perform Design and Permitting of Stormwater Management Improvements for The County of Salem; and

WHEREAS, two (2) qualified Firms responded to the "Request for Proposal and Qualifications" on October 23, 2024 at 11:00 am; and

WHEREAS, the Salem County Board of County Commissioners have determined that a need exists for the aforementioned Professional Services; and

WHEREAS, an evaluation of the Proposals based on the criteria outlined in the "Request for Proposals" resulted in **"TAYLOR WISEMAN & TAYLOR"** of Mounty Laurel, New Jersey receiving the recommendation of Award of Proposal from the "Review Committee"; and

WHEREAS, the "Request for Proposal and Qualifications" was solicited through a "Fair and Open" process in accordance with N.J.S.A. 19:44A-20.4 et seq; and

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

1. A Professional Services Contract be issued to **"TAYLOR WISEMAN & TAYLOR"** in accordance with their Proposal for "Auburn Road, County Road #602 Design and Permitting of Stormwater Management Improvements for the County of Salem" for their Total Amount of \$221,356.38 (Two Hundred Twenty-One Thousand, Three Hundred, Fifty-Six Dollars and Thirty-Eight Cents).
2. The Director and Clerk of the Salem County Board of County Commissioners are hereby authorized to execute the Contract for "Professional Services" subject to the approval of the County Solicitor.
3. A "Notice of Award" of said Professional Services Contract shall be published as required by law.
