**RESOLUTION ACCEPTING AND EXECUTING A GRANT FROM THE NEW JERSEY OFFICE OF INFORMATION TECHNOLOGY FOR FUNDING PSAP NEXTGEN 911 CALL HANDLING EQUIPMENT UNDER GRANT AWARD #FY25-100-137-017.**

**WHEREAS**, the Salem County Board of County Commissioners recognize the need to work with the County 911 Center to obtain funding that will allow the County to improve call handling capability of the PSAP in preparation for NextGen 911; and

**WHEREAS**, the New Jersey Office of Information Technology has offered funding to Salem County 911 Public Safety Answering Point (PSAP), for the purpose of purchasing a Motorola VESTA NextGen 911 capable phone system to replace outdated Zetron phone system; and

**WHEREAS**, the Salem County Board of County Commissioners accept that the FY-2025 Next Generation 9-1-1 Grants for the period of July 1, 2024, through June 30, 2025, in the awarded amount of \$947,882.56 (Nine Hundred Forty-Seven Thousand, Eight Hundred Eighty Two Dollars and Fifty Six Cents) to purchase Motorola VESTA CPE upgrades and approve.

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of County Commissioners that:

1. The project funding application as outlined and on file on the NJ.gov webpage.
2. The Salem County Sheriff’s Office Department of Emergency Services, the Chief Finance Officer, the project contact person from the Salem County Sheriff’s Office Department of Emergency Services, as well as any other necessary parties, are hereby authorized and directed to execute all grant requirements and documentation filings as directed by the New Jersey Office of Information Technology.
3. One fully executed copy of this resolution shall be provided to the Salem County Sheriff’s Office Department of Emergency Services forthwith.
