**RESOLUTION AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE STATE OF NEW JERSEY OFFICE OF THE INSURANCE FRAUD PROSECUTOR FOR THE PROSECUTOR'S OFFICE INSURANCE FRAUD REIMBURSEMENT PROGRAM FOR THE COUNTY OF SALEM**

**WHEREAS**, the Office of the Insurance Fraud Prosecutor has been designated by the Legislature to implement funding reimbursement for anti-insurance fraud activities, pursuant to N.J.S.A. 17:33A-28; and

**WHEREAS**, the Salem County Prosecutor's Office has received prior funding for anti-insurance fraud activities and wishes to apply for continued funding in the amount of \$250,000.00 (Two Hundred Fifty Thousand Dollars and Zero Cents) for an action plan under the reimbursement program beginning January 1, 2025 and running through December 31, 2025; and

**WHEREAS**, the Board of County Commissioners of the County of Salem recognizes the need to assist the Prosecutor's Office, the New Jersey Office of Insurance Fraud Prosecutor and law enforcement in an endeavor to effectively address the problem of insurance fraud in this County; and

**WHEREAS**, the project is a joint effort between the Office of the Insurance Fraud Prosecutor and the Salem County Prosecutor's Office for the purposes described in the application; and

**WHEREAS**, the Board of County Commissioners has reviewed the application on file with the Clerk of the Board and has approved said request.

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Board of County Commissioners as follows:

1. The project grant on file with the Clerk of the Board is supported and approved.
2. The Attorney General has allocated funds dedicated for the purpose of reimbursing County Prosecutors for anti-insurance fraud activities.
3. The Office of the Insurance Fraud Prosecutor shall receive, review, and approve applications for said funding.
4. The office of the Insurance Fraud Prosecutor shall receive and initiate allocations to each applicant as authorized.
5. The County Prosecutor, the Treasurer, the Project Contact Person from the Prosecutor's Office, as well as any other necessary parties are hereby authorized and directed to execute the application and all other appropriate grant documents.
