**RESOLUTION APPROVING THE EXECUTION OF CHANGE ORDER #2 TO THE
2023 LOCAL AID INFRASTRUCTURE FUND HOOK ROAD, COUNTY ROAD #551,
RECONSTRUCTION FOR THE COUNTY OF SALEM**

WHEREAS, the County of Salem issued a contract in the amount of \$ 282,867.37 (Two Hundred, Eighty-Two Thousand, Eight Hundred Sixty-Seven Dollars and Thirty-Seven Cents) to "Richard E. Pierson Construction Company, Inc." of Pilesgrove, New Jersey for the "2023 Local Aid Infrastructure Fund Hook Road, County Road #551, Reconstruction for the County of Salem" on March 20, 2024, per Resolution #2024-139; and

WHEREAS, the Salem County Board of County Commissioners adopted Resolution #2024-440 on October 16, 2024, authorizing Change Order #1 for an additional cost of \$8,508.00 (Eight Thousand, Five Hundred Eight Dollars and Zero Cents); and

WHEREAS, N.J.A.C. 5:30-11.1 requires that all Change Orders for Capital Projects be approved by the Board of County Commissioners; and

WHEREAS, the County Engineer and Administrator recommend the approval of Change Order #2 as more particularly described on the attached New Jersey Department of Transportation Local Aid Projects Change Order #2 Form and the County of Salem Change Order #2 Form which represents a Project Increase of \$12,869.06 (Twelve Thousand, Eight Hundred Sixty-Nine Dollars and Six Cents), which in addition to Change Order #1, represents a 7.6% INCREASE in the Total Contract Cost, resulting in a Total Contract Cost of \$304,244.43 (Three Hundred Four Thousand, Two Hundred Forty-Four Dollars and Forty-Three Cents); and

WHEREAS, this Project is funded through the New Jersey Department of Transportation, Local Aid Infrastructure Fund Program; and

WHEREAS, the purpose of this Change Order #2 is to approve Supplemental Items, as more particularly described on the attached New Jersey Department of Transportation Local Aid Projects Change Order #2 Form.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners that this Change Order #2 be and is hereby approved for execution for the "2023 Local Aid Infrastructure Fund Hook Road, County Road #551, Reconstruction for the County of Salem"; and

BE IT FURTHER RESOLVED that the Commissioner Director and the Clerk of this Salem County Board of County Commissioners be authorized to execute said NJDOT, Local Aid Projects Change Order #2 Form and the Salem County Change Order #2 Form for the project referenced above.
