**RESOLUTION DECLARING COUNTY-OWNED AMBULANCES AS SURPLUS AND UNNEEDED PROPERTY AND AUTHORIZING THE TRANSFER OF TITLE TO THE BOROUGH OF WOODSTOWN FOR THE DEPARTMENT OF EMERGENCY SERVICES FOR \$1 EACH**

**WHEREAS**, the Board of County Commissioners of the County of Salem received funding from the State of New Jersey to procure ambulances for the benefit of those municipalities whose ambulance coverage was/is at-risk; and

**WHEREAS**, the County procured such ambulances and is desirous of transferring the title of these vehicles that it deems as surplus and unneeded property:
