RESOLUTION AMENDING RESOLUTION 2025-264 AUTHORIZING SHARED SERVICE AGREEMENTS AND MEMORANDUMS OF UNDERSTANDING FOR THE PROVISION OF EMERGENCY MEDICAL SERVICES

WHEREAS, the Board of County Commissioners of the County of Salem (the "Board") adopted Resolution #2025-264 on June 18, 2025 with the following Municipalities and volunteer first aid, ambulance, and rescue squad associations to provide Emergency Medical and Ambulance Services within the County by paying the municipality or ambulance squads \$150 per call for all calls responded to by the Municipality or Ambulance Squad within the confines of the County of Salem:

Municipalities

- Carneys Point
- Lower Alloway's Creek
- Penns Grove
- Pennsville

Ambulance Squads

- American Legion Ambulance Association
- Elsinboro Fire Company
- Pedricktown First Aid & Rescue

; and

WHEREAS, the Board is desirous of amending these agreements, as permitted by Section 9.6 of the Shared Services Agreements and of the same for the Memorandums of Understanding (the "Agreements"), to extend the term expiration date from June 30, 2026, to December 31, 2026; and

WHEREAS, American Legion Ambulance Association would be excluded from this extension as they are no longer contracted by and through Salem County municipalities for EMS transports; and

WHEREAS, the Board is also desirous of clarifying the definition of a "call" as part of said amendment to include and be triggered by Patient Transports made in response to said "calls" as otherwise already included in the Agreements; and

WHEREAS, the Board further desires to add the Ambulance Squad known as Event Medical Staffing Solutions, contracted by and through the Borough of Woodstown effective January 1, 2026.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

1. That the Shared Service Agreements and Memorandums of Understandings between the County of Salem and the Municipalities and Ambulance Squads referenced in the

preamble hereto be amended to clarify the definition of the per call billing rate and simultaneously extend the term of the agreements from expiring June 30, 2026, to December 31, 2026.

2. That the same agreement(s) be applied to the Borough of Woodstown/Event Medical Staffing Solutions effective January 1, 2026, to December 31, 2026, under the same terms and conditions.

3. That the Director, or his designee, and the Clerk of the Board are hereby authorized to execute any and all documents to effectuate the full intent and purpose of these Agreements.

4. A copy of this Resolution shall be forwarded to the Division of Local Government Services.
