RESOLUTION AWARDING CONTRACTS FOR PROVIDING TEMPORARY ANIMAL SHELTERING SERVICES FOR THE MEMBERS OF THE SALEM COUNTY JOINT PURCHASING SYSTEM, SYSTEM IDENTIFIER #299SCJPS

WHEREAS, the County of Salem created the Salem County Joint Purchasing System, System Identifier #299SCJPS for the express purpose of engaging with potential vendors on behalf of the Members of this System ("Members") for the as-needed housing of animals; and

WHEREAS, the Members have previously and unsuccessfully been able to secure vendors to provide animal sheltering services for their municipalities through Fair & Open Requests for Proposals or through non-competitive solicitations; and

WHEREAS, having no contracted animal shelter in place creates a public exigency; and

WHEREAS, the County of Salem, on behalf of the Members, has secured the following vendors to be able to provide as-needed animal sheltering services on a temporary basis while the municipalities investigate and undertake a more permanent solution:

Monmouth County SPCA, Eatontown, NJ

Rabies Quarantines (<=10 days)	\$250.00/each (Dog/Cat)
Rabies Quarantines (>10 days)	\$20.00/per day
Medical Procedures Performed At Cost	
Sheltering of Stray Dogs/Cats	\$250.00/each
Animal Cruelty Inv. Holds	Case-by-Case (negotiated)

WHEREAS, this open-ended contract award amount is estimated to be valued at \$10,000 in the aggregate, across all vendors, for a term commencing January 1, 2026, and ending December 31, 2026; and

WHEREAS, this dollar amount is based on a reasonable estimate of the services required over the term and the County or its Members are not obligated to spend that amount; and

WHEREAS, no amount will be encumbered until such time as goods or services are ordered; and

WHEREAS, the Purchasing Agent and/or the CFO/Treasurer shall ascertain that there are available sufficient uncommitted funds held in trust for the Members to provide for payment; and

WHEREAS, the purchase order will encumber appropriate account numbers as determined by the CFO/Treasurer at the time the purchase order is created.

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners:

1. That the Director, Clerk of this Board, and/or the Purchasing Agent are hereby authorized and directed to enter into open-ended contracts with Monmouth County SPCA for the aforesaid services.
2. That all such costs shall be borne and charged by the Trust fund account established for the Member/Municipality and that the County shall impose no administrative fee in facilitating these activities.
