**RESOLUTION AWARDING A RENEWAL CONTRACT FOR THE POSITION OF
PSYCHOLOGICAL/PSYCHIATRIC SERVICES FOR THE SALEM COUNTY
CORRECTIONAL FACILITY**

WHEREAS, the Salem County Purchasing Department for the Board of County Commissioners of the County of Salem properly advertised seeking "fair and open" proposals for the position of Psychological/Psychiatric Services for the Salem County Correctional Facility, the receipt of which proposal was duly advertised in accordance with N.J.S.A. 19:44A-20.4 et seq. and in such case made and provided; and

WHEREAS, the Board of County Commissioners of the County of Salem adopted Resolution 2025-100 awarding a contract to CFG Health Systems, LLC; and

WHEREAS, the contract provided for two (2) additional one (1) year renewal options; and

WHEREAS, CFG Health Systems, LLC and the Salem County Board of County Commissioners are interested in exercising the first one (1) year renewal option of said contract with the same terms and conditions as outlined in the specifications and proposal.

WHEREAS, as a condition of the shared services agreement the County holds with the County of Gloucester, the latter shall be responsible for their proportionate share of the bill based on their proportionate total of the incarcerated persons population; and

WHEREAS, in an effort to display the approximate net cost to the County of Salem, it anticipates that the Gloucester share to be reasonably estimated at about 70%, rendering the net amount due from the County of Salem at approximately **\$328,857.**

NOW, THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

1. The Salem County Board of County Commissioners hereby awards a renewal contract for the position of Psychological & Psychiatric services for the Salem County Correctional Facility, subject to the review of the County Solicitor, to CFG Health Systems, LLC, PO Box 289, Marlton, NJ 08053 at the same rate of \$328,857.00 for a 12-month period.
2. The contract shall commence retroactively on March 1, 2026, and terminate on February 28, 2027, with one (1) year renewal or extension remaining. This shall be completed in full accordance with the terms and conditions of the contract.
3. The County Commissioner Director and the Clerk of the Board shall be authorized to execute said contract.
